Variation Order | Down-the-Wire Communications System

I refer to the contract between the Secretary of the NSW Ministry of Health constituted as the Health Administration Corporation under section 9 of the *Health Administration Act* 1982 (NSW) (**NSW Ambulance**) and Northern NSW Helicopter Rescue Service Pty Ltd (**Operator**) dated 16 December 2014 (Contract No HAC 13/63) as amended (**Contract**).

This letter is a Variation Order for the purposes of clause 21.7 of the Contract (Variation Order).

1 Background

- On 8 June 2022, NSW Ambulance issued a Variation Impact Request (Doc No. D22/6398) to the Operator setting out the details of a proposed Variation for the Operator to procure and operate a Down-the-Wire (DTW) communications system for the
- 1.2 On 8 August 2022, the Operator provided NSW Ambulance a Variation Impact Proposal (VIP).
- 1.3 NSW Ambulance did not accept the VIP, however NSW Ambulance and the Operator have reached agreement on various "disputed matters" in the VIP as contemplated by clause 21.7 of the Contract, and that agreement is reflected in this Variation Order.

2 Variation

2.1 The Variation which the Operator must implement is to procure, install, operate and maintain a DTW communications system for the with this Variation Order, including Attachment 1 (DTW Communication System Specification), Attachment 2 (Implementation Plan) and Attachment 3 (Net Loss).


